IMPORTANT INFORMATION: Your Privacy at Franklin Savings Bank

Personal Information Privacy Protection Policy

At Franklin Savings Bank, protecting the privacy and confidentiality of your personal information is important to our employees and to us. We value your business and the trust you put in Franklin Savings Bank. To offer you the financial products and services you seek, we collect, maintain, and use information about you on a routine basis. To help you better understand how your personal information is protected at Franklin Savings Bank, we are providing you with the following statement describing our practices and policies with respect to the privacy of customer information. In the event you terminate your customer relationship with us, or become an inactive customer, we will continue to adhere to the policies and practices described in this notice.

Information We Collect

As a trusted financial institution, we collect, retain, and use nonpublic personal information about individual customers, allowed by law, to provide products and services to our customers. We may collect nonpublic personal information from such sources as:

- Information we receive from you on applications or other forms;
- Information about your transactions with us;
- Information we receive from a consumer-reporting agency.

“Nonpublic personal information” is nonpublic information about you that we obtain in connection with providing a financial product or service to you. For example, nonpublic personal information includes information regarding your account balance, payment history, overdraft history.

What Information We Disclose

We are permitted under law to disclose nonpublic personal information about you to other third parties in certain circumstances. For example, we may disclose nonpublic personal information about you to third parties to assist us in servicing your loan or account with us, to government entities in response to subpoenas, and to credit bureaus. We do not disclose any nonpublic personal information about you to anyone, except as permitted by law.

Service Providers & Joint Marketing Partners

To provide our customers with products or services that we believe may meet your financial needs, we may exchange limited nonpublic personal information about you to other financial institutions in order to offer financial products or services pursuant to a joint agreement. Such information exchanged includes:

- Information we receive from you on applications or other forms, such as your name, address, and telephone number.

How We Protect Your Information

We understand that the protection of your nonpublic personal information is of the utmost importance. Guarding your privacy is our obligation. Franklin Savings Bank maintains strict procedures and policies to safeguard your privacy. Our policies restrict employee access to customer information only to those who have a business reason to know such information, and we educate our employees about the importance of confidentiality and customer privacy. Our policies prohibit our employees from giving information about you to anyone in a manner that would violate any applicable law or our privacy policy.
